



# New and Expanded Sleep Disorders Center Opens







ather Hospital has opened a new, expanded Sleep Disorders Center featuring eight beautifully furnished diagnostic testing bedrooms with queen-size beds, private bathrooms and showers, Wi-Fi, television and individual

temperature control. The new Sleep Center includes dedicated bedrooms for testing pediatric patients with sleeping accommodations for a parent, and a state-of-the-art central monitoring room for therapists to conduct sleep studies.

"The new sleep disorders center is a great addition to our program. It is better for the patients to get care and for the doctors to provide care," said Nick Patel, DO, a board certified pulmonologist and sleep specialist. "It's much easier for patients to get to the center now. We've increased our number of beds, increasing availability for patients to get scheduled quicker. It's a much more comprehensive center now too, offering X-ray capabilities (for chest x-rays), full PFT (Pulmonary Function Testing) machine and dedicated space to help patients with mask fitting and pressure tolerance."


Located on the first floor of the Frey Family Foundation Medical Arts Building adjacent to the Hospital, patients enter into a spacious reception area and waiting room. In addition to the eight adult and pediatric bedrooms, the Center has separate areas for pulmonary function testing; radiology imaging; consultation rooms; and a dedicated area for assisting patients in using a CPAP (Continuous Positive Airway Pressure) device. All Sleep Center physicians are board certified in sleep medicine. All sleep technologists are New York State licensed respiratory therapists with specialized training in sleep technology.

As the medical specialty of sleep disorders has grown, doctors have learned more about how a lack of a good night's sleep can impact a person's health. "Doctors are sending patients to us based on how sleep disorders can factor into other medical conditions – heart disease, neurologic

conditions, diabetes, high blood pressure, and obesity," Dr. Patel said. "They will orient the patient to what will happen that night, connect them to all diagnostic monitoring equipment and answer any questions or address any concerns that they have before starting the study," said Dr. Patel. "Then once the patient is asleep, the therapist using advanced patient monitoring collects high quality data, making any adjustments and any therapeutic interventions, if needed. The technologist monitors the patient throughout the night.

"We get many referrals from other doctors, primary care and subspecialists, because sleep disorders can affect many other medical conditions - heart disease including hypertension, neurological conditions including strokes and chronic headaches, diabetes and obesity," Dr. Patel said. "With pulmonary conditions - COPD, asthma, chronic sinus disease - a lot of these patients will have overlapping sleep disorders as well."










### **Brain & Spine Tumor Program Offers Advanced Diagnosis and Treatment of Tumors**



Having a brain tumor is devastating. Coordinating all the specialists needed to treat the tumor has just gotten easier.

Mather Hospital's Brain & Spine Tumor Program offers advanced diagnosis and treatment of tumors by a team of specialists that meet with the patient together in one location to determine a care plan.

"With all these modalities to provide patients with high-level neurology and neurological surgery care in their

community, they don't have to travel far," said Dr. Sumeer Sathi, a neurosurgeon and Co-Director of Mather's Brain & Spine Tumor Program. "They can have these things taken care of - including complicated spinal or brain surgery and tumor surgery - without having to go from doctor's office to doctor's office. The care is organized in one location.

"This is a unique center on Long Island. There is no other community hospital that offers all these services under one roof."

From 2014-2016, Mather experienced an 85 percent increase in neurosurgical brain and spine procedures

done at the hospital.

"The biggest advantage to the Brain & Spine Tumor Program is that the patient meets with all their specialists together in the same place at the same time. This allows for a quicker assessment and planning," said Medical Oncologist David Chu, MD, and Co-Director of the Brain & Spine Tumor Program. "The patient meets with a medical oncologist, a radiation oncologist, and the neurosurgeon at one visit and not through multiple visits spread over two or three weeks. At Mather, we will look at the case together and decide on the appropriate treatment and then have a discussion with the patient and their family."

The Brain & Spine Tumor Program is part of Mather's Neurosciences Center which also consists of Mather's Department of Neurosurgery, Precision CyberKnife of New York, the Back & Neck Pain Center, Stroke Center, advanced Imaging Services, and Outpatient Physical

Therapy and Rehabilitation Services.

### Patient Credits Lung Cancer Screening with Saving Her Life

Lorraine, a former smoker with a 35-year smoking history, had asthma since she was a child. In 2013, the Coram resident experienced difficulty in breathing and was struggling to get things done. She went to her pulmonologist, Dr. Jay Barbakoff, who recommended that she participate in the Lung Cancer Screening Program at Mather Hospital. The screening program is for individuals from 55 to 77 years old AND who have at least a 30 "pack year" smoking history (average of one pack a day for 30 years), and currently smoke or quit in the last 15 years.

Lorraine met Eileen Zaoutis, RN, nurse navigator for the program, and the entire process was completed in a half hour. Mather uses an advanced 320-slice CT scanner to perform the test at the lowest possible radiation dose. Lorraine's scan took less than five minutes and revealed that she had nodules on her lung.

A subsequent biopsy indicated that the nodes were cancerous. Lorraine had guit smoking 15 years prior and never thought she had lung cancer.

Thoracic surgeon Dr. Gregory Brevetti surgically removed her left upper lobe and all the surrounding 17 lymph nodes. Chemotherapy was required to make sure the cancer didn't spread to the other lung. Within a month, she went back to work. Lorraine follows up with her oncologist, Dr. William Li Pera.

"People don't know how important it is to be screened ahead of time," said Lorraine. "I'm just so grateful that mine was caught early." Lorraine explained that Eileen was



constantly following up with her to make sure she was feeling fine. "Eileen made it so I didn't feel alone," she said. "She was my go-to person and she was always there for me along with my supportive family."

Lorraine is happy that she can breathe when walking from her home to her car without having to stop, as she did before her surgery. She credits Mather's Lung Cancer Screening Program with saving her



## **Brothers Lose Almost 300 Pounds, Transform Their Lives**





Paul, left, lost about 165 pounds. John, right, lost about 125 pounds.

Brothers John and Paul are seven years apart in age and about three years ago each tipped the scale at more than 325 pounds. John weighed 330 pounds and younger brother Paul was approaching 400 pounds. Both struggled with weight all their lives.

"I had been going to Weight Watchers", not going to Weight Watchers", trying one of these protein diets, the Zone Diet". Nothing ever worked," said John, 52. "In 2014 I retired as an EMS medic with the FDNY. Just sitting home with food always in front of me, I was ballooning up. The last

"I feel great, much healthier than I was. I have more energy"-Paul five years I worked I had a desk job and I wasn't making good choices. I was always at the bagel store. I never packed a lunch. I was always going out to get something."

Paul, 45, had his own weight problems, topping out at 395 pounds. He heard people at work talking about Dr. Arif Ahmad, the Director of Mather's Center of Excellence in Metabolic and Bariatric Surgery™. "I attended the seminar, and then I scheduled an appointment and had a meeting with him. Dr. Ahmad recommended the gastric sleeve," he said.

Paul told his brother about Dr. Ahmad and he, too, scheduled an appointment and was told the gastric sleeve would be his best option as well. The two ended up having their procedures on the same day in April 2015 at Mather Hospital. Today, John weighs 205 pounds, Paul about 230.

"It was phenomenal. The hospital is nice, the people are really great," John said. "I had nothing but a great experience in that facility, and the same with Dr. Ahmad's staff."

Paul said he notices the difference in everything he does. "I feel great, much healthier than I was. I have more energy," he said. "It's a totally different lifestyle. I'm getting out more as opposed to sitting on the couch all the time. I volunteer at an ambulance corps and I can get around and move patients easier. I even feel better at work. I'm not as conscious about my weight."

### Mather Names 2017 Community Honoree and Theodore Roosevelt Award Winners

Mather Hospital will honor Suffolk County Police Commissioner Timothy D. Sini and physicians Ahmad F. Bhatti, MD, and Philip Nizza, DO, and at its annual One Enchanted Evening Gala on Friday, Nov. 3 at East Wind Long Island in Wading River.

Each year, Mather selects a special Community Honoree who has supported the Hospital and its programs over the years. The Theodore Roosevelt Awards - created by the Nassau-Suffolk Hospital Council more than 50 years ago honors those who demonstrate exceptional volunteer commitment to a member hospital and its community.



#### Community Honoree — Timothy D. Sini

Timothy D. Sini was appointed the 13th Commissioner of the Suffolk County Police Department in January 2016. The Sini family has long been associated with Mather Hospital. Tim's father, Frank, is retired from the hospital as Assistant Vice President of Finance and his uncle John Sini has served on Mather's Board of Directors since 1982. Commissioner

Sini has spoken at Mather's Annual EMS Dinner and participated in the Port Jefferson Yacht Club's Village Cup Regatta which supports Palliative Care at Mather Hospital.

As Police Commissioner, Sini has focused on enhancing the intelligenceled policing model, improving community relations, and investing in new technology to enhance the Department's operations. The Department has launched numerous successful criminal initiatives aimed at addressing the opioid epidemic, firearm violence, and traffic fatalities in Suffolk County.

Commissioner Sini serves as a representative on the White House's Office of Drug Control Policy New York/New Jersey Regional HIDTA Team. He is also the Executive Director of the Suffolk County Criminal Justice Coordinating Council.

Prior to his appointment as Commissioner, Commissioner Sini served as the Assistant Deputy County Executive for Public Safety in the administration of Suffolk County Executive Steven Bellone. He previously served as Assistant United States Attorney in the Criminal Division of the U.S. Attorney's Office for the Southern District of New York.

He is a magna cum laude graduate of Brooklyn Law School, where he earned his Juris Doctor degree, and American University in Washington, D.C., where he received his Bachelor of Arts degree in Political Science. He lives in Babylon Village with his wife, Amanda, and their three children.

#### **Theodore Roosevelt Award Winners** Ahmad F. Bhatti, MD

Dr. Bhatti is the immediate past president of Mather's Medical Staff and past Chairman of the Medical Board. He has also held many other positions on



the Medical Board including Vice Chair/Vice President and Member at Large and has served on various committees including the Continuing Medical Education Committee, Infection Prevention Committee, Bylaws Committee, Quality Management Committee and Credentials Committee. He has also served as a board member of the Suffolk County Medical Society and practices at North Shore

Vascular Surgery in Port Jefferson.

After receiving his undergraduate degree from Stevens Institute of Technology in Hoboken, NJ, Dr. Bhatti went on to earn his medical degree from the University of Medicine & Dentistry of New Jersey. He completed both an internship and residency in general surgery at St. Luke's-Roosevelt Hospital Center (NY) and was a Vascular Research Fellow at the same institution. Dr. Bhatti completed a Fellowship in Vascular Surgery at Loyola University Medical Center in Maywood, IL before joining Mather's staff in 2006.

Dr. Bhatti is a Registered Vascular Technologist and Registered Physician in Vascular Interpretation, certifications regarding advanced vascular laboratory testing. He is board certified in general and vascular surgery.

Dr. Bhatti lives in Setauket with his wife, Zynub, and five children.



#### Philip Nizza, DO

Dr. Nizza has been a member of Mather Hospital's medical staff since 2002. He received his undergraduate degree from New York University and attended medical school at the New York College of Osteopathic Medicine. Dr. Nizza then completed an Internal Medicine Residency at North Shore University Hospital. His Infectious Disease training was

done at Memorial Sloan Kettering Cancer Center.

For the past 15 years, Dr. Nizza has been with Eastern Infectious Disease Associates, practicing infectious disease at four local hospitals, and more recently providing care at the long-term nursing facility, Island Nursing and Rehabilitation Center. He has been on the Pharmacy and Therapeutics Committees since 2002, and serves as co-chairman where he was instrumental to the team that created the Antimicrobial Stewardship Program.

The goal is to change the antibiotic ordering culture and reduce inappropriate utilization. As a result of this program, the total number of antibiotic therapy days has been reduced by 14% in the first 15 months and Mather's Clostridium difficile rate is below the New York State benchmark.

He lives in East Setauket with his wife, Natalie - also a physician whom he has known since he was a medical student - and their two sons.


